- **Sep 25, 2008:** The title of the measure was amended. Agreed to without objection.
- **Sep 23, 2008:** Mr. Scott (GA) moved to suspend the rules and agree to the resolution, as amended.
- **Sep 23, 2008:** Considered under suspension of the rules. (consideration: CR H8643-8645; text of measure as introduced: CR H8643-8644)
- **Sep 23, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1461.
- **Sep 23, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Ms. Ros-Lehtinen objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.

- **Sep 18, 2008:** Referred to the House Committee on Foreign Affairs.
