Summary (as of Sep 24, 2008)

Sets forth the rule for consideration of the Senate amendment to H.R. 2638 (Consolidated Security, Disaster Assistance, and Continuing Appropriations Act, 2009). Agrees to the Senate amendment with an amendment printed in the accompanying report of the Committee on Rules.

Requires the chairman of the Committee on Appropriations to insert in the daily issue of the Congressional Record dated September 24, 2008, such material as he may deem explanatory of the motion to agree.

Actions Timeline

- **Sep 24, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-875, by Mr. McGovern.
- **Sep 24, 2008:** It shall be in order to take from the Speaker's table the bill H.R. 2638, with the Senate amendment thereto and to move to agree to the Senate amendment with an amendment printed in the report of the Committee on Rules accompanying this resolution.
- **Sep 24, 2008:** Placed on the House Calendar, Calendar No. 270.
- **Sep 24, 2008:** By the direction of the Committee on Rules, Mr. McGovern called up H. Res. 1488 and asked for its immediate consideration.
- **Sep 24, 2008:** Mr. Flake proposed a point of order against the provisions of H. Res. 1488 by stating the resolution violates the Congressional Budget Act. The Chair announced the disposition of the point of order would be resolved by the question of consideration of H. Res. 1488. The House proceeded with ten minutes of debate on the point of order at the end of which the Chair will put the question on consideration.
- **Sep 24, 2008:** Mr. McGovern moved that the House now consider the resolution.
- **Sep 24, 2008:** Will the House now consider the resolution Agreed to by the Yeas and Nays: 242 - 168 (Roll no. 628).
- **Sep 24, 2008:** Considered as privileged matter. (consideration: CR H9218-9231)
- **Sep 24, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1488.
- **Sep 24, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 231 - 198 (Roll no. 629). (consideration: CR H9228-9230)
- **Sep 24, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 202 (Roll no. 630).(text: CR H9218)
- **Sep 24, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 202 (Roll no. 630). (text: CR H9218)
