Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to allow consideration or disposition of a measure (making FY2009 supplemental appropriations for job creation and preservation, infrastructure investment, and economic and energy assistance) on the same day it is presented to the House.

 reported from the Rules Committee) against certain resolutions reported from the Rules Committee. The rule applies
 the waiver to any resolution reported on the legislative day of September 26, 2008, providing for consideration or
 disposition of a measure making supplemental appropriations for job creation and preservation, infrastructure
 investment, and economic and energy assistance for the fiscal year ending September 30, 2009, and for other
 purposes.
