Actions Timeline

- **Sep 26, 2008:** Introduced in House
- **Sep 26, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-891, by Mr. McGovern.
- **Sep 26, 2008:** All points of order against consideration of the bill are waived except those arising under clause 10 of rule XXI.
- **Sep 26, 2008:** Placed on the House Calendar, Calendar No. 280.
- **Sep 26, 2008:** Considered as privileged matter. (consideration: CR H10059-10074)
- **Sep 26, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1507.
- **Sep 26, 2008:** During the course of debate, exception was taken to certain words used and a demand was made to have words taken down. Mr. Obey asked unanimous consent to withdraw the words. Without objection the words were withdrawn. The House resumed debate on H.Res. 1507.
- **Sep 26, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 218 - 204 (Roll no. 657). (consideration: CR H10073)
- **Sep 26, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 213 - 208 (Roll no. 658).(text: CR H10059)
- **Sep 26, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 213 - 208 (Roll no. 658). (text: CR H10059)
