William H. Frist Gift of Life Congressional Medal Act of 2007 - Directs the Secretary of the Treasury to design and strike a bronze medal to commemorate organ donors and their families.

Requires the Secretary of Health and Human Services to direct the entity holding the Organ Procurement and Transplantation Network to contract to establish an application procedure and determine eligibility.

Allows the Secretary of Health and Human Services or the Network contractor to provide duplicates of the medal to any recipient.

Allows the Secretary of the Treasury to enter into an agreement with the Network contractor to collect funds to offset expenditures relating to the issuance of medals, which the Secretary shall deposit in the Numismatic Public Enterprise Fund.

- Mar 30, 2007: Sponsor introductory remarks on measure. (CR E725)
- Mar 30, 2007: Referred to the Subcommittee on Health.
- Mar 29, 2007: Introduced in House
- Mar 29, 2007: Referred to the Committee on Financial Services, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
