(This measure has not been amended since it was reported to the Senate on December 12, 2007. The summary of that version is repeated here.)

Chimp Haven is Home Act - Amends the Public Health Service Act to repeal provisions providing for the removal of surplus chimpanzees from a sanctuary facility. Prohibits use of such chimpanzees for research except for noninvasive behavioral studies.
