Internet Gambling Study Act - Requires the National Research Council of the National Academy of Sciences to conduct a comprehensive study of Internet gambling, including the existing legal framework that governs such activities and transactions and the impact of the Unlawful Internet Gambling Enforcement Act on Internet gambling in the United States.

Actions Timeline

- Jul 28, 2008: Subcommittee on Crime, Terrorism, and Homeland Security Discharged.
- Jun 4, 2007: Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- May 3, 2007: Introduced in House
- May 3, 2007: Referred to the Committee on the Judiciary, and in addition to the Committees on Financial Services, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
