## Summary (as of May 9, 2007)

Medicare Access to Complex Rehabilitation and Assistive Technology Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to exempt complex rehabilitation products and assistive technology products from the Medicare competitive acquisition program.

## Actions Timeline

- **May 15, 2007:** Referred to the Subcommittee on Health.
- **May 9, 2007:** Introduced in House
- **May 9, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 9, 2007:** Referred to the Subcommittee on Health.
