Summary (as of May 15, 2007)

Syria Accountability and Liberation Act - States that U.S. sanctions, controls, and regulations relating to Syria shall remain in effect until the President certifies that Syria has ceased support for terrorism, has dismantled biological, chemical, or nuclear weapons programs and has committed to combat their proliferation, respects the boundaries and sovereignty of all neighboring countries, and upholds human rights and civil liberties.

Imposes specified trade, assistance, and military sanctions, as appropriate, on persons or countries that transfer goods or technology so as to contribute to Syria's biological, chemical, nuclear, or advanced conventional weapons programs.

Imposes specified sanctions aimed at Syria's energy sector.

Sets forth diplomatic measures intended to isolate the government of Syria.

Directs the President to provide assistance to support a democratic transition in Syria. Authorizes appropriations.

Actions Timeline

- **May 18, 2007:** Referred to the Subcommittee on Trade.
- **May 15, 2007:** Introduced in House
- **May 15, 2007:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on Ways and Means, Financial Services, and Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
