Stop Marketing Illegal Drugs to Minors Act - Amends the Controlled Substances Act to impose increased prison terms on individuals who manufacture, create, distribute, or possess with intent to distribute a controlled substance that is flavored, colored, packaged, or otherwise altered in a way that is designed to appeal to a person under 21 years of age (or who attempt or conspire to do so). Provides for enhanced penalties for repeat offenses involving the marketing of methamphetamine to minors.

### **Actions Timeline**

- **Jun 25, 2007:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 22, 2007:** Introduced in House
- **May 22, 2007:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 22, 2007:** Referred to the Subcommittee on Commerce, Trade and Consumer Protection.
