**Summary** (as of May 22, 2007)

Equal Protection for All Workers Act - Amends the Occupational Safety and Health Act to specifically include any individual employed under contract among employees whose deaths resulting from employers' willful violations of standards under the Act subject such employers to criminal penalties.

#### **Actions Timeline**

- Jul 17, 2007: Referred to the Subcommittee on Workforce Protections.
- Jun 25, 2007: Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- May 22, 2007: Introduced in House
- May 22, 2007: Referred to the Committee on Education and Labor, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
