No related bills are listed.

Amends the the Illegal Immigration Reform and Immigrant Responsibility Act of 1996 to require federal contractors and subcontractors (as defined by this Act) to participate in the employment eligibility verification pilot program.

Directs the Attorney General to ensure that the pilot program is applied to all of the contractor's or subcontractor's employees and not just to those performing the contract or subcontract.

Actions Timeline

- Jul 24, 2007: Referred to the Subcommittee on Workforce Protections.
- Jun 25, 2007: Referred to the Subcommittee on Immigration, Citizenship, Refugees, Border Security, and International Law.
- May 24, 2007: Introduced in House
- May 24, 2007: Referred to the Committee on the Judiciary, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
