Summary (as of Jun 12, 2007)

Military Spouses Employment Act of 2007 - Amends the Internal Revenue Code to include spouses of members of the Armed Forces on extended active duty (more than 90 days or for an indefinite period) as members of a targeted group for purposes of the work opportunity tax credit (thus giving employers a tax incentive for hiring military spouses).

Repeals certain restrictions on disposals to foreign nations of naval vessels in excess of 3,000 tons or less than 20 years of age.

Actions Timeline

- **Jun 28, 2007:** Referred to the Subcommittee on Military Personnel.
- **Jun 12, 2007:** Introduced in House
- **Jun 12, 2007:** Referred to the Committee on Ways and Means, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
