- **Mar 28, 2007:** Considered as privileged matter. (consideration: CR H3199-3203)
- **Mar 28, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 274.
- **Mar 28, 2007:** The previous question was ordered without objection. (consideration: CR H3203)
- **Mar 28, 2007:** POSTPONED PROCEEDINGS - At conclusion of the debate on H. Res. 274, the Chair put the question on the resolution and by voice vote, announced the ayes had prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on the resolution until later in the legislative day.
- **Mar 28, 2007:** Considered as unfinished business. (consideration: CR H3204-3205)
- **Mar 28, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 243 - 179 (Roll no. 204).(text: CR H3199-3200)
- **Mar 28, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 28, 2007:** On agreeing to the resolution Agreed to by the Yeas and Nays: 243 - 179 (Roll no. 204). (text: CR H3199-3200)
- **Mar 27, 2007:** Introduced in House
- **Mar 27, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-78, by Ms. Castor.
- **Mar 27, 2007:** Rule provides for consideration of H.R. 1538 with 1 hour and 20 minutes of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions.
- **Mar 27, 2007:** Placed on the House Calendar, Calendar No. 35.
