Actions Timeline

- **Mar 28, 2007:** Considered as privileged matter. (consideration: CR H3192-3199)
- **Mar 28, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 275.
- **Mar 28, 2007:** POSTPONED PROCEEDINGS - At conclusion of the debate on H. Res. 275, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
