Medicare Medical Nutrition Therapy Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to authorize expansion of Medicare coverage of medical nutrition therapy services to diseases, conditions, or disorders other than diabetes or a renal disease.

#### **Actions Timeline**

- Jul 5, 2007: Referred to the Subcommittee on Health.
- Jun 22, 2007: Sponsor introductory remarks on measure. (CR E1386)
- Jun 21, 2007: Introduced in House
- Jun 21, 2007: Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Jun 21, 2007: Referred to the Subcommittee on Health.
