**Summary** (as of Jun 22, 2007)

Children's Health Protection Act of 2007 - Amends the Employee Retirement Income Security Act of 1974 (ERISA), the Public Health Service Act, and the Internal Revenue Code to prohibit a group health plan from imposing any preexisting condition exclusion for individuals who have not attained 19 years of age.

Applies such requirement to coverage offered in the individual market.

### **Actions Timeline**

- Jun 27, 2007: Referred to the Subcommittee on Health.
- Jun 22, 2007: Introduced in House
- Jun 22, 2007: Referred to the Committee on Energy and Commerce, and in addition to the Committees on Education and Labor, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Jun 22, 2007: Referred to the Subcommittee on Health.
