Wartime Enforcement of Fraud Act of 2008 - Amends the federal criminal code to revise provisions that suspend the statute of limitations for wartime frauds against the United States by: (1) making such provisions applicable to an authorization for the use of Armed Forces (currently, applicable only if a war has been declared); (2) extending such limitation period from three to five years after the termination of hostilities; and (3) requiring a presidential proclamation, with notice to Congress, to signal the end of hostilities and thus end the suspension of the statute of limitations.

- Jul 25, 2008: Placed on Senate Legislative Calendar under General Orders. Calendar No. 899.
- Jun 26, 2008: Committee on the Judiciary. Ordered to be reported without amendment favorably.
- Apr 18, 2008: Introduced in Senate
- Apr 18, 2008: Sponsor introductory remarks on measure. (CR S3174-3175)
- Apr 18, 2008: Read twice and referred to the Committee on the Judiciary. (text of measure as introduced: CR S3175)
