### Summary (as of Jun 28, 2007)

Preventing Diabetes in Medicare Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to extend Medicare coverage to medical nutrition therapy services for people with pre-diabetes and risk factors for developing type-2 diabetes.

### Actions Timeline

- **Jul 6, 2007:** Referred to the Subcommittee on Health.
- **Jun 28, 2007:** Introduced in House
- **Jun 28, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 28, 2007:** Referred to the Subcommittee on Health.
