Summary (as of Jul 14, 2008)

Recognizes the 60th anniversary of President Truman's executive order declaring a policy of equality of treatment and opportunity for all persons in the armed services without regard to race, color, religion, or national origin, thereby beginning the process of ending segregation in the U.S. Armed Forces.

- Jul 15, 2008: Received in the Senate and referred to the Committee on Armed Services.
- Jul 14, 2008: Mr. Courtney moved to suspend the rules and agree to the resolution, as amended.
- Jul 14, 2008: Considered under suspension of the rules. (consideration: CR H6424-6426)
- Jul 14, 2008: DEBATE The House proceeded with forty minutes of debate on H. Con. Res. 297.
- Jul 14, 2008: At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- Jul 14, 2008: Considered as unfinished business. (consideration: CR H6448)
