Summary (as of Jul 12, 2007)

Medicare Early Detection of Cancer Promotion Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to: (1) extend the eligibility period for a "Welcome to Medicare" initial preventive physical examination from six months to one year; and (2) to eliminate the 20% coinsurance for screening mammography and colorectal cancer screening tests.

Actions Timeline

- **Jul 16, 2007:** Referred to the Subcommittee on Health.
- **Jul 12, 2007:** Introduced in House
- **Jul 12, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jul 12, 2007:** Referred to the Subcommittee on Health.
