Summary (as of Jul 17, 2007)
Medicare Part D Drug Class Protection Act of 2007 - Amends part D (Voluntary Prescription Drug Benefit Program) of title XVIII (Medicare) of the Social Security Act to require that Medicare prescription drug plans using formularies cover a drugs included in six specified therapeutic categories.
Sets forth special requirements for reconsideration of coverage determinations, and appeals for drugs included in such categories.
Establishes reporting requirements for drugs in these categories.
Actions Timeline
 Jul 17, 2007: Introduced in House Jul 17, 2007: Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned. Jul 17, 2007: Referred to the Subcommittee on Health.
