Providing for consideration of the bill (H.R. 1905) to provide for the treatment of the District of Columbia as a Congressional district for purposes of representation in the House of Representatives, and for other purposes and providing for consideration of the bill (H.R. 1906) to amend the Internal Revenue Code of 1986 to adjust the estimated tax payment safe harbor based on income for the preceding year in the case of individuals with adjusted gross income greater that \$5 million.

If either H.R. 1905 of H.R. 1906 fails of passage or fails to reach the question of passage by an order of recommittal, then both such bills, together with H.R. 1433, shall be laid on the table. In the engrossement of H.R. 1905, the Clerk shall append the text of H.R. 1906, as passed by the House, as new matter at the end of H.R. 1905. Upon that action, H.R. 1906 and H.R. 1433 shall be laid on the table.
