Sets forth the rule for consideration of H.R. 363 (Sowing the Seeds Through Science and Engineering Research Act).

## Actions Timeline

- **Apr 24, 2007:** Considered as privileged matter. (consideration: CR H3800-3802)
- **Apr 24, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 318.
- **Apr 24, 2007:** The previous question was ordered without objection. (consideration: CR H3802)
- **Apr 24, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 318, the Chair put the question on adoption of the resolution and by voice vote, announced the yeas had prevailed. Mr. Cardoza demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day.
- **Apr 24, 2007:** Considered as unfinished business. (consideration: CR H3803-3804)
- **Apr 24, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 187 (Roll no. 249).(text: CR H3800)
- **Apr 24, 2007:** On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 187 (Roll no. 249). (text: CR H3800)
- **Apr 24, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 18, 2007:** Introduced in House
- **Apr 18, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-99, by Mr. Cardoza.
- **Apr 18, 2007:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Science and Technology now printed in the bill.
- **Apr 18, 2007:** Placed on the House Calendar, Calendar No. 40.
