- **Apr 19, 2007:** AMENDMENT MODIFICATION - Ms. Matsui asked unanimous consent that during consideration of H.R. 1495, amendment number 1 printed in House Report 110-100 be considered in a modified form. Agreed to without objection.
- **Apr 19, 2007:** The previous question was ordered without objection. (consideration: CR H3568)
- **Apr 19, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H3566)

- **Apr 18, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-100, by Ms. Matsui.
- **Apr 18, 2007:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill.
