Summary (as of Jul 27, 2007)

Dog Fighting Prohibition Act - Amends the Animal Welfare Act to make it unlawful to: (1) knowingly sponsor or exhibit an animal in, or knowingly attend, a dog fighting venture; and (2) knowingly sell, buy, possess, train, transport, deliver, or receive for purposes of transportation any dog or other animal for the purposes of having the dog, animal, or offspring of the dog or other animal participate in a dog fighting venture. Provides for imprisonment for up to five years for violations.

Actions Timeline

- **Apr 25, 2008:** Referred to the Subcommittee on Livestock, Dairy, and Poultry.
- **Sep 10, 2007:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Jul 27, 2007:** Introduced in House
- **Jul 27, 2007:** Referred to the Committee on Agriculture, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
