Summary (as of Sep 18, 2007)

Directs the Attorney General, subject to the availability of funds, to: (1) provide a grant to i-Safe, Inc., to carry out Internet safety education programs; and (2) create and administer a competitive grants program for organizations to carry out Internet safety education programs. Defines "Internet safety education programs" to mean programs that educate parents, children, educators, and communities about Internet technology and culture, appropriate online behavior, and recognition and prevention of Internet dangers.

Actions Timeline

- **Nov 8, 2007:** Referred to the Subcommittee on Telecommunications and the Internet.
- **Oct 12, 2007:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Sep 18, 2007:** Introduced in House
- **Sep 18, 2007:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
