Intelligence Authorization Act for Fiscal Year 2007 - Authorizes appropriations for FY2007 for the conduct of intelligence and intelligence-related activities of the: (1) Office of the Director of National Intelligence (DNI); (2) Central Intelligence Agency (CIA); (3) Department of Defense; (4) Defense Intelligence Agency; (5) National Security Agency; (6) Departments of the Army, Navy, and Air Force; (7) Departments of State, the Treasury, Energy, and Justice; (8) Federal Bureau of Investigation; (9) National Reconnaissance Office; (10) National Geospatial-Intelligence Agency; (11) Coast Guard; (12) Department of Homeland Security; and (13) Drug Enforcement Administration.

Specifies that the amounts authorized and the authorized personnel ceilings as of September 30, 2007, for those activities are those specified in the classified Schedule of Authorizations.

Allows the DNI, with the approval of the Director of the Office of Management and Budget, to authorize employment of civilian personnel in excess of the number authorized for FY2007 (by not more than two percent) when necessary to the performance of important intelligence functions.

Authorizes appropriations for the Intelligence Community Management Account of the DNI for FY2007 as well as for full-time personnel for elements within such Account.

Authorizes appropriations for FY2007 for the Central Intelligence Agency Retirement and Disability Fund.

Specifies that the authorization of appropriations by this Act shall not be deemed to constitute authority for the conduct of any intelligence activity which is not otherwise authorized by the Constitution or laws of the United States.

Revises various DNI authorities and duties concerning access to, and sharing of, intelligence information.

Amends the National Security Act of 1947 to establish an Office of the Inspector General of the Intelligence Community. Repeals superseded authority to establish such position under the Inspector General Act of 1978.

Establishes within the Office of the DNI a National Space Intelligence Center.

Protects from public disclosure certain operational files within the Office of the DNI.

Establishes a Deputy Director of the CIA.
