Sets forth the rule for consideration of H.R. 1873 (Small Business Fairness in Contracting Act).

Actions Timeline

- **May 9, 2007:** Considered as privileged matter. (consideration: CR H4643-4646)
- **May 9, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 383.
- **May 9, 2007:** The previous question was ordered without objection. (consideration: CR H4646)
- **May 9, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 383, the Chair put the question on adoption of the resolution and by voice vote, announced the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of resolution until later in the legislative day.
- **May 9, 2007:** Considered as unfinished business. (consideration: CR H4655)
- **May 9, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 197 (Roll no. 312).(text: CR H4643)
- **May 9, 2007:** On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 197 (Roll no. 312). (text: CR H4643)
- **May 9, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **May 8, 2007:** Introduced in House
- **May 8, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-137, by Mr. Cardoza.
- **May 8, 2007:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Oversight and Government Reform now printed in the bill.
- **May 8, 2007:** Placed on the House Calendar, Calendar No. 58.
