Summary (as of Oct 23, 2007)

Medicare Prescription Drug Savings and Choice Act of 2007 - Amends part D (Voluntary Prescription Drug Benefit Program) of title XVIII (Medicare) of the Social Security Act to provide for: (1) establishment of one or more Medicare operated prescription drug plan options; (2) an appeals process for denials of benefits under a Medicare operated prescription drug plan; and (3) pharmacy payments under such a plan.

Actions Timeline

- **Nov 9, 2007:** Referred to the Subcommittee on Health.
- **Nov 8, 2007:** Referred to the Subcommittee on Health.
- **Oct 23, 2007:** Introduced in House
- **Oct 23, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
