Urges: (1) the United States not to engage in the construction of a North American Free Trade Agreement (NAFTA) Superhighway System; (2) the United States not to allow the Security and Prosperity Partnership to implement regulations that would create a North American Union with Mexico and Canada; and (3) the President to oppose these acts or any other proposals that threaten U.S. sovereignty.

Actions Timeline

- **Jan 23, 2007:** Referred to the Subcommittee on Highways and Transit.
- **Jan 22, 2007:** Introduced in House
- **Jan 22, 2007:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
