Sets forth the rule for consideration of H.R. 1427 (Federal Housing Finance Reform Act of 2007).

Actions Timeline

- **May 17, 2007:** Considered as privileged matter. (consideration: CR H5338-5343)
- **May 17, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 404.
- **May 17, 2007:** The previous question was ordered without objection. (consideration: CR H5343)
- **May 17, 2007:** POSTPONED PROCEEDINGS - At the conclusion of the debate on H. Res. 404, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption until later in the legislative day.
