Summary (as of Nov 1, 2007)

Medicare Cervical Cancer Screening and Detection Coverage Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to provide for Medicare coverage of screening tests for human papillomavirus (HPV) associated with a higher risk of cervical cancer.

Actions Timeline

- **Nov 9, 2007:** Referred to the Subcommittee on Health.
- **Nov 1, 2007:** Introduced in House
- **Nov 1, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
