## Summary (as of Nov 13, 2007)

Requires the Secretary of Transportation to withhold specified graduated percentages of a state's apportionment of certain federal-aid highways funds for FY2010 and thereafter if driver licenses or personal identification cards issued by the state do not meet with certain minimum federal standards to be accepted by a federal agency.

## Actions Timeline

- **Nov 14, 2007:** Referred to the Subcommittee on Highways and Transit.
- **Nov 13, 2007:** Introduced in House
- **Nov 13, 2007:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
