- **Jun 26, 2008:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR 6/24/2008 H5970)
- **Jun 26, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 24, 2008:** Mr. Filner moved to suspend the rules and pass the bill.
- **Jun 24, 2008:** Considered under suspension of the rules. (consideration: CR H5970-5972)
- **Jun 24, 2008:** DEBATE - The House proceeded with forty minutes of debate on H.R. 4264.
- **Jun 24, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Buyer objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
