- **May 24, 2007:** Considered as privileged matter. (consideration: CR H5730-5738)
- **May 24, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 438.
- **May 24, 2007:** POSTPONED PROCEEDINGS - At the conclusion of the debate on H. Res. 438, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **May 24, 2007:** UNFINISHED BUSINESS - The Chair announced that the unfinished business was the question on ordering the previous question which had been debated earlier and on which further proceedings had been postponed.
- **May 24, 2007:** Considered as unfinished business. (consideration: CR H5747-5749)
- **May 24, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 221 - 199 (Roll no. 417). (consideration: CR H5738, H5747-5748)
