Summary (as of Jan 12, 2007)

Crack-Cocaine Equitable Sentencing Act of 2007 - Amends the Controlled Substances Act and the Controlled Substances Import and Export Act to eliminate specified mandatory minimum penalties relating to the trafficking in, and possession, importation, or distribution of, crack cocaine.

- **Feb 2, 2007:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Feb 2, 2007:** Referred to the Subcommittee on Health.
- **Jan 12, 2007:** Introduced in House
- **Jan 12, 2007:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
