Amends title IV part D (Child Support and Establishment of Paternity) of the Social Security Act to provide for the mandatory revocation of passports of individuals who are more than \$5,000 in arrears in child support payments.

Actions Timeline

- **Jan 16, 2007:** Referred to the Committee on Ways and Means, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
