Actions Timeline

- **Jul 23, 2007:** Ms. Jackson-Lee moved to suspend the rules and agree to the resolution.
- **Jul 23, 2007:** Considered under suspension of the rules.
- **Jul 23, 2007:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 535.
- **Jul 23, 2007:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Jul 23, 2007:** ORDER OF PROCEDURE - Mr. Welch asked unanimous consent that the proceedings by which the yeas and nays were ordered on the motion to suspend the rules and agree to H.Res. 535 be vacated to the end that the Chair put the question de novo. Agreed to without objection.
