United States-Republic of Korea Defense Cooperation Improvement Act of 2008 - Amends the Arms Export Control Act to include the Republic of Korea among those countries given preferential consideration with respect to certain: (1) arms export presidential certification and legislative review requirements; and (2) military training reporting requirements.

- **Oct 2, 2008:** Read twice and referred to the Committee on Foreign Relations.
- **Sep 24, 2008:** Received in the Senate.
- **Sep 23, 2008:** Mr. Higgins moved to suspend the rules and pass the bill.
- **Sep 23, 2008:** Considered under suspension of the rules. (consideration: CR H8626-8628)
- **Sep 23, 2008:** DEBATE - The House proceeded with forty minutes of debate on H.R. 5443.
- **Sep 23, 2008:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H8626-8627)
- **Sep 23, 2008:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H8626-8627)
- **Sep 23, 2008:** Motion to reconsider laid on the table Agreed to without objection.
