## Summary (as of Feb 14, 2008)

Prohibits any federal funds from being provided to a state, city, county, or other political subdivision thereof if the Secretary of Defense determines that such state or political subdivision prohibits or unreasonably restricts, through zoning requirements more restrictive than those imposed on most small businesses in that jurisdiction, the ability of the Armed Forces to establish and operate a military recruiting office.

Requires the Secretary to notify the President and Congress of each such determination.

- **Feb 14, 2008:** Sponsor introductory remarks on measure. (CR H973)
- **Feb 14, 2008:** Referred to the Committee on Armed Services, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
