Providing for consideration of the bill (H.R. 2831) to amend title VII of the Civil Rights Acts of 1964, the Age Discrimination in Employment Act of 1967, the Americans With Disabilities Act of 1990, and the Rehabilitation Act of 1973 to clarify that a discriminatory compensation decision or other practice that is unlawful under such Act occurs each time compensation is paid pursuant to the discriminatory compensation decision or other practice, and for other purposes.

Actions Timeline

- **Jul 30, 2007:** Considered as privileged matter. (consideration: CR H8905-8912)
- **Jul 30, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 579.
- **Jul 30, 2007:** POSTPONED PROCEEDINGS - At the conclusion of the debate on H.Res. 579, the Chair put the question on ordering the previous question and by voice vote, announced that the yeas had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.

- **Jul 30, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 27, 2007:** Introduced in House
- **Jul 27, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-263, by Ms. Sutton.
- **Jul 27, 2007:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The amendment in the nature of a substitute recommended by the Committee on Education and Labor now printed in the bill shall be considered as adopted.
- **Jul 27, 2007:** Placed on the House Calendar, Calendar No. 93.
