Sets forth the rule for consideration of H.R. 3161 (Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2008).

Actions Timeline

- **Jul 31, 2007:** Considered as privileged matter. (consideration: CR H9212-9219)
- **Jul 31, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 581.
- **Jul 31, 2007:** POSTPONED PROCEEDINGS - At the conclusion of the debate on H.Res. 581, the Chair put the question on ordering the previous question and by voice vote, announced that the yeas had prevailed. Mr. Hastings (WA) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Jul 31, 2007:** Considered as unfinished business. (consideration: CR H9227)
- **Jul 31, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 228 - 197 (Roll no. 769). (consideration: CR H9227)
- **Jul 31, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H9212)

- **Jul 27, 2007:** Introduced in House
- **Jul 27, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-265, by Mr. McGovern.
- **Jul 27, 2007:** Rule provides for consideration of H.R. 3161 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be read by paragraph. Bill is open to amendments.
- **Jul 27, 2007:** Placed on the House Calendar, Calendar No. 95.
