Sets forth the rule for consideration of H.R. 3162 (Children's Health and Medicare Protection Act of 2007)

Actions Timeline

- Aug 1, 2007: The House Committee on Rules reported an original measure, H. Rept. 110-285, by Ms. Castor.
- Aug 1, 2007: Rule provides for consideration of H.R. 3162 with 2 hours of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Bill is closed to amendments.
- Aug 1, 2007: Placed on the House Calendar, Calendar No. 96.
- Aug 1, 2007: Ms. Castor called up the resolution for consideration.
- Aug 1, 2007: DEBATE The House proceeded with twenty minutes of debate on Mr. Sessions point of order that the resolution violates section 426(a) of the Congressional Budget Act of 1974. In accordance with section 426(b)(2) of the Act, Mr. Sessions met the threshold burden to identify the specific language in the resolution on which the point of order is predicated. Pursuant to section 426(b)(3) of the Act, after that debate the Chair will put the question of consideration.
- Aug 1, 2007: On motion to consider the resolution. Agreed to by the Yeas and Nays: 222 197 (Roll no. 782).
- Aug 1, 2007: Considered as privileged matter. (consideration: CR H9287-9298, H9299-9302)
- Aug 1, 2007: DEBATE The House proceeded with one hour of debate on H. Res. 594.
- Aug 1, 2007: DEBATE The House resumed debate on H. Res. 594.
- Aug 1, 2007: On ordering the previous question Agreed to by the Yeas and Nays: 228 190 (Roll no. 784). (consideration: CR H9300-9301)
