Medicaid and SCHIP Abuse Prevention Act of 2008 - Amends titles XIX (Medicaid) and XXI (State Children's Health Insurance) (SCHIP) of the Social Security Act to place a ceiling on an individual's eligibility for Medicaid and SCHIP benefits at a gross family income that is not more than 250% of the poverty level.
