Summary (as of May 23, 2007)

Returning Servicemember VA Healthcare Insurance Act of 2007 - Extends, for veterans who served in a theater of combat operations during a period of war after the Persian Gulf War or during a period of hostilities after November 11, 1998, from two to five years the period of eligibility for hospital care, medical services, or nursing home care provided by the Secretary of Veterans Affairs following discharge or release for such veterans, or, for veterans who were discharged or released more than five years before the enactment of this Act and who did not enroll before such enactment, enrollment must be within three years of such enactment.

- **May 24, 2007:** Received in the Senate and Read twice and referred to the Committee on Veterans' Affairs.
- **May 23, 2007:** Mr. Filner moved to suspend the rules and pass the bill, as amended.
- **May 23, 2007:** Considered under suspension of the rules. (consideration: CR H5662-5664)
- **May 23, 2007:** DEBATE - The House proceeded with forty minutes of debate on H.R. 612.
- **May 23, 2007:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **May 23, 2007:** Considered as unfinished business. (consideration: CR H5681)
