Summary (as of Jun 11, 2008)

Requires that the Cape Hatteras National Seashore, North Carolina, be managed in accordance with the Interim Protected Species Management Strategy/Environmental Assessment issued by the National Park Service (NPS) until the NPS issues a special regulation and long-term off-road vehicle management plan for the use of that seashore by the public.

Invalidates the consent decree filed in the United States District Court for the Eastern District of North Carolina regarding off-road vehicle use at that seashore.

Actions Timeline

- **Jul 28, 2008:** Referred to the Subcommittee on Courts, the Internet, and Intellectual Property.
- **Jun 13, 2008:** Referred to the Subcommittee on National Parks, Forests and Public Lands.
- **Jun 11, 2008:** Introduced in House
- **Jun 11, 2008:** Referred to the Committee on Natural Resources, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
