- **Sep 7, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 637, the Chair put the question of agreeing to the resolution and by voice vote, announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on the question of agreeing to the resolution until later in the legislative day.
