## Actions Timeline

- **Sep 19, 2007:** Considered as privileged matter. (consideration: CR H10516-10524)
- **Sep 19, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 660.
- **Sep 19, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 660, Mr. Arcuri moved the previous question and by voice vote, the Chair announced that the noes had prevailed. Mr. Arcuri demanded the Yeas and Nays which were ordered, and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Sep 19, 2007:** Considered as unfinished business. (consideration: CR H10525-10526)
- **Sep 19, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 224 - 197 (Roll no. 879). (consideration: CR H10523-10524, H10524-10525)
- **Sep 19, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 223 - 195 (Roll no. 880).(text: CR H10516-10517)
- **Sep 19, 2007:** On agreeing to the resolution Agreed to by recorded vote: 223 - 195 (Roll no. 880). (text: CR H10516-10517)
- **Sep 19, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 18, 2007:** Introduced in House
- **Sep 18, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-333, by Mr. Arcuri.
- **Sep 18, 2007:** All points of order against consideration of the bill except clauses 9 and 10 of Rules XXI. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Financial Services now printed in the bill, modified by the amendment printed in Part A of this report, shall be considered as adopted. The rule makes in order only those further amendments printed in Part B of this report.
- **Sep 18, 2007:** Placed on the House Calendar, Calendar No. 117.
