- **Sep 18, 2008:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR 9/17/2008 H8331)
- **Sep 18, 2008:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR 9/17/2008 H8331)
- **Sep 18, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 17, 2008:** Ms. McCollum (MN) moved to suspend the rules and pass the bill.
- **Sep 17, 2008:** Considered under suspension of the rules. (consideration: CR H8331-8332)
- **Sep 17, 2008:** DEBATE - The House proceeded with forty minutes of debate on H.R. 6772.
- **Sep 17, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Ms. Foxx objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Sep 10, 2008:** Ordered to be Reported by Voice Vote.
- **Aug 1, 2008:** Introduced in House
- **Aug 1, 2008:** Referred to the House Committee on Oversight and Government Reform.
